#### **Description:**

SANDBLASTING UNIT @ ECHO SITE consisting of: Empire Super 350, Serial # P-14018 is portable, located at Echo Site MTC yard and is identified by JPL with Serial No. 4140.

#### **CONDITIONS:**

1. This unit shall only use abrasives that have been certified by the California Air Resources Board (CARB).
2. Abrasive blasting operations within any permanent building shall not discharge into the atmosphere emissions which have an opacity of 10% or greater.
3. Dry abrasive blasting using ARB-approved abrasive and no other control shall be used only on surfaces sufficiently free of excess deposits to prevent emissions >20% opacity for more than three minutes in any one hour.
4. The owner/operator, o/o, shall operate this equipment in strict accord with the manufacturer's specifications and/or sound engineering principles.
5. The o/o shall maintain a log which contains the weight of abrasive blast materials used, dates, and times of use. The log shall be maintained current, on-site (with the unit) for a minimum of 5 years and provided to District personnel on request.
