CONDITIONS:

- 1. All equipment shall be maintained in good operating condition and shall be operated in a manner to minimize emissions of air contaminants into the atmosphere.

- 2. The blasting operations shall only be carried out inside the blasting cabinet which is exhausted to the fully operational dust collector specified under this permit.

- 3. The HEPA filters required for use in this Air Filtration Device shall be certified by the manufacturer to have a minimum control efficiency of 99.97% on 0.3 micron particles.

- 5. Emissions of chromate compounds limited to 0.003 lb/year (based on SDS for coatings removed and assumption that 1% of uncontrolled emissions is coating particulate).

- e. record of repairs/maintenance/filter cartridge replacements
