- 1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or in a manner consistent with safety and good air pollution control practices for minimizing emissions. Furthermore, operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit is issued.

  [District Rule 1303(B)]
- 2. This equipment is limited to using only commercially available natural gas for fuel. [District Rule 431]
- 3. This boiler system shall be equipped with a meter measuring fuel consumption in cubic feet or therms. [District Rule 1303(B)]
- 4. The owner/operator shall maintain a current, on-site (at a central location if necessary) log for this equipment for two (2) years, which shall be provided to District, State or Federal personnel upon request. This log shall include the following:
- a) The hours each of the seven (7) boilers operated per month;
- b) Total monthly fuel usage for this boiler system in cubic feet, therms, and/or Btus; and
- c) The date each boiler is tuned. [District Rules 204 and 1303]
- 5. These boilers are to be tuned and tested annually per manufacturer's specifications. [District Rule 1303]
- 6. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
