- 2. This facility shall only be powered by line power or a District permitted generator.? [District Rule 204]
- 3. This equipment shall not be operated unless the baker tank is vented to a properly functioning bin vent. [District Rule 1320]
- 4. Conveyors and transfer points shall either be fully covered or the materials processed shall contain sufficient natural or added moisture to ensure compliance with all applicable District Rules such as those in Regulation IV. Sufficient water and equipment to properly wet the material being processed shall be maintained in operable condition on-site.

 [District Regulation IV]
- 5. Sufficient natural and/or added water shall be maintained in the materials added to the hopper in the description above to preclude violations of District Rules 401, 402 and 403. Adequate supplies of water and the necessary equipment to add it to the material entering the hopper shall be maintained on-site and used as necessary. This condition also applies to haul roads and other roads at the facility where this equipment is used.
- 6. PM-10 emissions from this facility, excluding those from fugitive sources, shall be less than 15 tons per year (tpy). [District Rule 1303]
- 7. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
