DUST COLLECTOR, PEBBLE CaO SILO consisting of: Diversified Storage Systems, WAM 400 PJ Dust Collector, Serial No. TBD, pulse jet type, having 27 polyester filter cartridges; 5.25" O.D. x 30" H, filter area 387 sq. ft., flow rate 2,200 cfm, (air to cloth ratio 6:1), 7.5 bhp fan, fan size 18" Diam. Normal operating pressure is 8-15 PSI, measured at the load line. 98.4% control efficiency.
