Description:

DUST COLLECTOR consisting of: Camfil Air Pollution Control Dust Collector, Model GSX24, Serial Number M16099001, pulse jet type, having 24 filters (16.5" O.D. x 29" H), filter area 275 sq. ft., flow rate 14,000 cfm, air to cloth ratio 2.12:1, 48.8 bhp fan. Filters are rated at 85% control efficiency (MERV 11). This dust collector controls emissions from an exempted equipment consisting of one TORXX Kinetic Pulverizer TKP #5. Exemption granted by Deputy Director per District Rule 201 for negligible emissions. Exemption status saved with application.

CONDITIONS:

- 1. The owner/operator shall operate and maintain this dust collector in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles.

- 2. Visible emissions from this equipment shall not exceed an opacity equal to, or greater than, twenty percent (20%) for a period aggregating more than three (3) minutes in any one (1) hour, excluding uncombined water vapor [District Rule 401]. This equipment shall not discharge air contaminants or materials constituting a nuisance to any considerable number of persons or to the public [District Rule 402]. Roadways, work areas and stockpiles shall be kept sufficiently moist to control fugitive dust, and no visible emissions shall extend beyond the property line of the emission source [District Rule 403]. Equipment to properly wet the material being processed and/or preclude emissions shall be maintained in operable condition on-site and used as necessary to assure compliance with this condition [District Rule 204].
- 3. The owner/operator shall conduct a minimum program of inspection and maintenance on this equipment. The owner/operator shall

maintain current and on-site for five (5) years a log of the following information, which shall be provided to District personnel upon request:?

- a. Quarterly bag and bag suspension system inspection date and results;
- b. Quarterly differential pressure readings date and result;
- c. Date of bag replacements; and,
- d. Date and nature of any system repairs.?

- 4. Dust collected by the control equipment shall be maintained in closed containers.? [District Rule 1302]
- 5. All doors, hatches, and airlocks shall remain secured and closed during operation of this equipment. [District Rules 431 and 1302]
- 6. The?owner/operator shall maintain on-site, as a minimum, an inventory of replacement filter cartridges that assures compliance with applicable Rules of District Regulation IV.
- 7. This air pollution control device must operate concurrently with the operation of the exempted equipment TORXX Kinetic Pulverizer TKP #5. [District Rule 204]
- 8. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
