EMERGENCY INTERNAL COMBUSTION ENGINE (Commissary Bldg 364) consisting of:

One Cummins MC #389099, Diesel fired internal combustion engine Model No. VTA 2862 and Serial No. 37112464, producing 900 bhp with cylinders at 1800 rpm while consuming a maximum of . This equipment powers a DMT Corp Generator Model No. 600-C and Serial No. 191, rated at 500kW; 625 KVA; 752 Amps;177/420 Volts at 1800 rpm.

#### **CONDITIONS:**

- 1. Operation of this equipment shall be conducted in accordance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below.
- 2. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants.
- 3. This unit shall be limited to use for emergency power, defined as when commercially available power has been interrupted, and as part of a testing program which does not exceed 60 minutes of operation per week.
- 4. The owner/operator (o/o) shall use only diesel fuel whose sulfur concentration is less than or equal to 0.05% on a weight per weight basis in this unit.
- 5. The o/o shall maintain a log for this unit, which, at a minimum, contains the information specified below. This log shall be maintained current and on-site for a minimum of two (2) years and shall be provided to District personnel on request:
