The o/o shall not use any motor vehicle or mobile equipment coating that contains hexavalent chromium or cadmium (Section 17 CCR 93112 - Airborne Toxic Control Measure for Emissions of Hexavalent Chromium and Cadmium from Motor Vehicle and Mobile Equipment Coatings).
