- 1. This equipment must not be operated unless it is vented to operating air pollution control equipment covered by all five valid District permits C000149 (42-003), C000150 (42-014), C000151 (42-017), C000153 (42-004), and C000154 (42-018).
- 2. The owner/operator (o/o) shall comply with all District Rules and Regulations including, but not limited to, malfunction/breakdown notifications.
- 3. The o/o shall have a continuing program of maintenance/inspections in accord with manufacturer's recommendations and specifications which ensures compliance with District Rules.
- 4. The o/o shall maintain a log of all inspections, repairs, and maintenance on this equipment and submit it to the District upon request. The log shall be kept for a minimum period of two years.
