- 1. This equipment must not be operated unless it is vented to operating air pollution control equipment covered by all four valid District permit C001956 (45-014),.
- 2. The owner/operator (o/o) shall comply with all District Rules and Regulations including, but not limited to, malfunction/breakdown notifications.
- 3. The o/o shall have a continuing program of maintenance/inspections in accord with manufacturer's recommendations and specifications which ensures compliance with District rules.
- 4. The o/o shall maintain a log of all inspections, repairs, and maintenance on this equipment and submit it to the District upon request. The log shall be kept for a minimum period of two years.
