BOILER, HEATER FIRETUBE TYPE consisting of: Heatek, Model No HCC40133030, with an Industrial Combustion Low Nox Gas Fired Burner, 6,300,000 Btu/hr, an Induced Flue Gas Recirculation System and a 5 HP blower, Serial No H88012A.

### **CONDITIONS:**

- 1. Operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below.
- 2. This equipment shall be properly maintained and kept in good operating condition at all times.
- 3. This boiler shall be operated in full compliance with all applicable District Rules and Regulations.
- 4. This boiler shall be fired with Natural Gas or Propane only.
- 5. A mechanical gauge shall be installed and maintained to indicate the amount of flue gas recirculated from the exhaust stack to the burner.
- 6. The Flue Gas Recirculation system (FGR) shall recirculate at least 15% of the flue gas from the exhaust stack to the burner of the boiler, whenever the boiler is operating between 10% through 100% load.

- 7. The FGR shall be in use whenever the boiler load is 10% or greater.
- 8. The low NOx boilder shall be equipped with a control system to automatically regulate the combustion air and fuel as the boiler load varies. This automatic control system shall be adjusted and tuned at least twice a year, according to the manufacturer's specifications to assure its ability to repeat the same performance at the same burner firing rate.
- 9. This boiler shall emit no more than 40 ppm for oxides of nitrogen (NOx), calculated as NO2, and 400 ppm of carbon monoxide (CO), all measured by volume on a dry basis at 3% oxygen.
