1. Operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below.

3. The owner/operator (o/o) shall not operate this permitted equipment simultaneously with equipment on District Permit B007389.
4. The o/o shall use only diesel fuel whose sulfur concentration is equal or less than 0.05% on a weight basis. The o/o may use the fuel supplier's furnished certification of sulfur content if the certifications are maintained on file.
5. Materials processed by equipment delineated above shall contain sufficient and/or added moisture to ensure compliance with District Rules 401 and 403. Sufficient water and equipment in operable condition shall be maintained on-site and used as necessary to ensure compliance with these rules.
6. The o/o shall maintain a log of the date, time of use and throughput in tons/hr. The log shall be kept current, on-site for a minimum of 2 years and provided to District personnel on request.
