## CONDITIONS:

1. This equipment must be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants. Unless otherwise noted, this equipment must also be operated in accordance with all data and specifications submitted with the application for this permit.

2. Belt Conveyors 131BC101 and 131BC102 shall not be operated unless it is vented to baghouse C007421 (131BF101). Belt Conveyor 131BC104 shall not be operated unless vented to baghouse C007422 (131BF102). Apron Feeder 132AF101 and Belt Conveyor 132BC101 shall not be operated unless vented to baghouse C007423 (132BF101).  
[District Rules 204, 1303(A)]

3. Materials processed shall contain sufficient natural and/or added moisture to ensure compliance with District Rules, such as, but not limited to, 401, 402, and 403. Sufficient water and equipment to properly wet the material being processed shall be maintained in operable condition and used as necessary to ensure compliance.  
[District Rules 401, 403]

4. "131" equipment (belt conveyor 131BC101 to dome 131DM101, stacker 131ST200 to storage pile) generating fugitive emissions shall not discharge into the atmosphere emissions that exhibit greater than ten percent opacity.  
[District Rules 401, 403; 40 CFR 60.672(b)]

5. "132" equipment (storage piles to apron feeder 132AF101) generating fugitive emissions shall not discharge into the atmosphere emissions that exhibit greater than twenty percent opacity.  
[District Rules 401, 403]

6. All equipment shall be operated in compliance with applicable requirements of 40 CFR 60, Subpart OOO - New Source Performance Standards for Nonmetallic Mineral Processing Plants or 40 CFR 63, Subpart LLL - National Emission Standard for Hazardous Air Pollutants from the Portland Cement Manufacturing Industry.
