The owner/operator shall maintain an operations log for this equipment, current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State or Federal personnel on request. This log shall include, at a minimum the following for each day of use:
- a. The number and types of items heated;
- b. The daily hours of operation;
- c. The total amount of natural gas consumed, in standard cubic feet;
- d. Cumulative rolling consecutive twelve month total hours of operation; and
- e. Descriptions of all malfunctions and corrective actions taken.
