BIODIESEL IC ENGINE, PORTABLE COMPRESSOR ID # 26-350 consisting of:

One Detroit, Diesel fired internal combustion engine Model No. 8V71 and Serial No. 7083-7000, producing 350 bhp with 8 cylinders at 2200 rpm while consuming a maximum of 18.0 gal/hr. This equipment powers a Joy/Gardner-Denver Compressor Model No. 1050 and Serial No. 70261, rated at 1050 CFM.

CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.
- 2. This unit shall only be fired on biodiesel fuel whose sulfur concentration is less than or equal to 0.0015% or (15 ppm) on a weight per weight basis.
- 3. A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time.
- 4. This portable bio-diesel-fueled engine (unit) shall burn only 100% rated biodiesel fuel, B100 or 99% rated biodiesel, B99.
- 5. The o/o shall maintain a current operations log for this unit for a minimum of five (5) years, and shall provide the log to District, State or Federal personnel upon request. The log shall include, at a minimum, the information specified below:
- a. Date and location on a monthly basis;
