2. This equipment shall be vented to properly functioning district permitted diesel fueled internal combustion engines covered under district permits; B011031 or M011032.

3. This gasifier unit shall not process more than 60 pounds of sorted solid waste from the range per hour. [Rule 204 - Permit Conditions; Version in SIP = CARB Ex. Order G-73, 40 CFR 52.220(c)(39)(ii)(B) -11/09/78 - 43 FR 52237; Current Rule Version = 07/25/77]

4. The o/o shall maintain a operations log for this unit current and on-site (or at a central location) for a minimum of two (2) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:

a) Date and total number of hours operated daily;

b) Start and stop time of each operating cycle;

c) Type and amount (in pounds) of waste processed daily;

d) Amount of gas generated daily;

e) Date and time of all alarms, upsets and/or malfunctions; and

f) A description of all repairs or maintenance performed by date.

5. Owner/operator shall not discharge into the atmosphere a visible emission with a shade as dark or darker than Ringelmann 1, or with an opacity of 20% or greater, for a period aggregating more than three minutes in any one hour.

6. This equipment is being evaluated as a waste to energy project for the US Military; as such this equipment is temporary and shall be removed from the site within 60 days of evaluation commencement.

7. This facility shall emit less than the following on a calendar year basis;

Oxides of Nitrogen (NOx) - 25 tons,

Volatile Organic Compound (VOC) - 25 tons,

Particulate Matter less than 10 microns (PM10) - 15 tons, and

Hazardous Air Pollutants (HAP) - 10 tons per year for any single HAP and 25 tons per year for any combination of HAPs.

Compliance shall be demonstrated annually to the District through the submission of a District approved Comprehensive Emission Inventory Report (CEIR) or other District approved equivalent method. The report shall be submitted to the District no later than April 30 of each year.
