BOILER #1, NATURAL GAS consisting of: Parker Direct Boiler model T5700, Rated with a maximum heat input of 4.995 MMBTU/Hr, fired only with natural gas and a fuel consumption rate of 4,897 scf/hr.

#### CONDITIONS:

- 1. Operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below.

- 2. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants.

- 3. The operator shall maintain a log for this equipment, which, at a minimum, contains the information specified below. This log shall be maintained current and on-site for a minimum of two (2) years and shall be provided to District personnel on request:
- a. Cumulative annual fuel use in cubic feet or operation in hours; and,
- b. Annual tune-up verification, if the O/O choices this compliance option, pursuant to Rule 1157 as paraphrased in Condition 5. [District Rule 204]
- 4. This boiler shall only be fueled with utility grade natural gas.

- 5. This Boiler is permitted as a Low annual heat input permit units, as defined in Rule 1157 Section (B), as such this device shall:
- (i) be operated in a manner that maintains stack-gas oxygen concentration at less than or equal to 3.0 percent by volume on a dry basis; or
- (ii) be operated with a stack-gas oxygen trim system set at 3.00+/-0.15 percent oxygen by volume on a dry basis; or
- (iii) be tuned at least annually in accordance with the procedure described in Section (I), a modification of the tuning procedure described in Section (I) as approved by the APCO, or the permit nit manufacturer's specified tune-up procedure, by a technician that is qualified, to the satisfaction of the Air Pollution Control Officer, to perform a tune-up; or
- (iv) be operated in compliance with the applicable emission levels specified in subsection Rule 1157(C)(4)(a). [District Rule 1157]
