- 3. A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed unit operating time. [District Rule 1303, basis: compliance verification]
- 4. The owner/operator shall maintain an operations log for this equipment on-site and current for a minimum of two (2) years, and said log shall be provided to District personnel on request. The operations log shall include the following information at a minimum:
- a. Total operation time (hours per month and an annual total); and,
- b. Total fuel consumed on an annual basis.

5. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
