- 2. This unit shall only be fired on ultra-low sulfur diesel fuel whose sulfur concentration is less than or equal to 0.0015% (15 ppm) per CARB Diesel or equivalent requirements; or alternative diesel fuel or CARB diesel fuel utilizing fuel additives that has been verified through the Verification Procedure for In-Use Strategies to Control Emissions from Diesel Engines. [Title 17 CCR 93116.3(a)]
- 3. This engine and its associated equipment cannot be operated at the same location (footprint) for more than 365 consecutive days. This system must be moved for a valid business purpose annually. [Title 17 CCR 93116.2(bb)] [District Rules 1302, 1303, and 1320]
- 4. A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time. [Title 17 CCR 93116.4(c)(2)(A)]
- 5. This facility is currently designated as a Small Fleet as defined in 17 CCR 93116, therefore this engine cannot be operated within the District on or after 01/01/2023. In the event additional portable diesel engines are permitted by the facility that raise the total combined bhp rating of all portable engines exceeds 750 bhp, then the facility will be classified as a Large Fleet and the engine will not be able to operate within the District on or after 01/01/2022.

- 6. The owner/operator shall maintain an operations log for this unit current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:
- a. Records of all repairs, maintenance, and testing;
- b. Monthly operation in terms of fuel consumption (in gallons) or total hours;
- c. Twelve consecutive month operation in terms of fuel consumption (in gallons) or total hours; and,
- d. Fuel sulfur concentration (the owner/operator may use the supplier's certification of sulfur content if it is maintained as part of this log).

- 7. The only GPUs authorized to operate at this facility are the following District permitted GPUs: B008751, B012496, and B013800. [District Rules 1302 and 1320]
- 8. This engine shall not operate for more than 600 hours in any consecutive 12-month period. [District Rules 1302 and 1320]
- 9. This unit is subject to the requirements of the Airborne Toxic Control Measure (ATCM) for Portable Compression Ignition Engines (Title 17 CCR 93116). In the event of conflict between these conditions and the ATCM, the more stringent requirements shall govern. [Title 17 CCR 93116, District Rule 1302]
- 10. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
