- 2. This engine shall not be operated unless all of the following engine systems are properly functioning:?
- a. Direct Injected
- b. Turbo Charged?
- c. Charge Air Cooler?
- d. Engine Control Module
- e. Engine Gas Recirculation

Furthermore, no changes shall be made to any of the above systems unless done so by a factory certified technician. [District Rule 1302]

- 3. This equipment shall only be fired on diesel fuel that meets the following requirements, or an alternative fuel approved by the ATCM for Stationary CI Engines:?
- a. Ultra-low sulfur concentration of 0.0015% (15 ppm) or less, on a weight per weight basis; and,
- b. A cetane index or aromatic content, as follows: ?
- ? 1. A minimum cetane index of 40; or, ?
- ? 2. A maximum aromatic content of 35 volume percent.

Note: Use of CARB certified ULSD fuel satisfies the above requirements.

- 4. A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time. [17 CCR 93115.10(d)(1) and 40 CFR 60.4209(a)]
- 5. This engine shall not operate more than 10 hours per day, 6-days/week, and no more than 26 weeks at this location and shall not operate more than 1560 (10 hrs/Day X 6 Days/Wk X 26 Wks). Additionally, this Engine shall not combust more than 40,872 gallons of Diesel fuel during the alotted time frame; 26.2 Gal/hr (75% Load Factor) X 1560 hrs. [District Rule 1302]
- 6. The owner/operator shall maintain an operations log for this unit, current and on-site (or at a central location), for a minimum of three (3) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:?
- a. Daily hour meter reading when engine is started and daily hour meter when engine is shut down; engine operation shall not exceed 10-hours per day.?
- b. Calendar year operation in terms of total hours; shall not exceed 1560 hours;??
- c. Fuel used by Engine, including weekly, monthly and calendar year totals; Not To Exceed 40,872 gallons.
- d. Fuel sulfur concentration (may use the fuel supplier's certification of sulfur content if it is maintained as part of this log).
- [17 CCR 93115, District Rules 1302 and 1320]
- 7. This engine is subject to the requirements of Title 17 CCR 93115, the Airborne Toxic Control Measure (ATCM) for Stationary Compression Ignition Engines and 40 CFR 60, Subpart IIII Standards of Performance for Stationary Compression Ignition Internal Combustion Engines (NSPS). In the event of a conflict between these conditions and the ATCM or NSPS, the more stringent requirements shall govern.

8. This facility has the potential to emit NOx at levels that are close to the Districts Major source threshold of 25 tons per year. As such this facility is a Federally Reportable Facility and shall NOT emit criteria pollutants in quantities that exceed the following Limits:

PM-10; shall not exceed 14.9 TPY NOx; shall not exceed 24.9 TPY SOx: shall not exceed 24.9 tpy VOC's: shall not exceed 24.9 tpy [District Rules 204 and 1303]

9. This facility is considered temporary and the associated Health Risks have been determined accordingly. Therefore, and pursuant to

the OEHHA 2015 Guidance Document, this facility shall NOT operate more than 10 hrs per day and no more than 6 days per week and no more than 1560 hours at this location. Note: This condition may be updated when the owner/operator receives permits for Tier IV Final Diesel equipped Gensets; presently the facility is permitted to operate with Tier IV Interim engines operating with valid district permits B013029 and B013032. To ensure compliance, the owner/operator shall notify the District upon startup, which shall include the facility name, contact, information, and date of startup, as a minimum. E-mail this information to Reporting@mdaqmd.ca.gov. [District Rule 1320]

10. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
