- 3. This equipment shall not be operated unless the associated Cement and Fly Ash Silos are vented only to an integrally attached Bin Vent with pulse jet type dust collectors. [Rule 404; Rule 405; Rule 204]
- 4. This equipment and associated operations shall not discharge an exhaust stream that exhibits opacity greater than twenty percent (Ringlemann 1). [Rule 401]
- 5. This equipment shall not produce more than 1,445,400 cubic yards of concrete per year. [Regulation XIII]
- 6. The o/o shall ensure that the materials used in the equipment contain sufficient natural and/or added moisture to preclude violations of District rules 401, 402, 403 and Regulation XIII. These rules pertain to opacity, dust blowing off of the property, nuisance and new source review. The o/o shall maintain sufficient water and equipment for its application in operable condition and on-site, and use it as necessary on material piles, haul roads, and in the plant to prevent violations of the above rules. [Rule 204]
- 7. The owner/operator shall maintain an operations log for this equipment, and shall contain at a minimum the following information. This log shall be maintained current and on-site for a minimum of two years, and shall be provided to District personnel upon request.
- a. Daily, monthly, and annual production (in cubic yards batched) records;
- b. Date and nature of any system repairs; and
- c. Date and nature of air pollution control device repairs or bag/filter cartridge replacements. [Rule 204]
- 8. This equipment shall be only be powered using grid power or an electrical generator driven by an internal combustion engine?with a valid District permit.?
 [Regulation XIII]
- 9. The equipment unit shall not reside at the same location for more than 12 consecutive months.? [Regulation XIII]
- 10. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
