- 3. The owner/operator shall maintain an operations log for this equipment on-site and current for a minimum of two (2) years, and said log shall be provided to District personnel on request. The operations log shall include the following information at a minimum:
- a. Records of all maintenance, repairs, and tune-ups; and,
- b. Total fuel consumed on an annual basis:? Fuel consumption can be calculated based on fuel purchase records, dedicated fuel meter readings, or other District approved method.

- 4. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
