- 1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 1302]
- 2. The owner/operator shall ensure that the materials used in the equipment contain sufficient natural and/or added moisture to preclude violations of District rules 401, 402 and 403. These rules pertain to opacity, dust blowing off of the property and nuisance. The owner/operator shall maintain sufficient water and equipment for its application in operable condition and on-site, and use it as necessary on material piles, haul roads, and in the plant to prevent violations of the above rules. [District Rule 1302]
- 3. Cement and Fly Ash Truck unloading shall only occur through a properly operating pneumatic truck unloading system, and only into designated storage silos.

[District Rules 204 & 1303]

- 4. Cement/fly ash guppies, silos, weight batcher, and horizontal mixer out shall be vented to a properly operating Baghouse, operating under valid District Permit C014429. [District Rules 204 & 1303]
- 5. All open material transfer points, such as conveyor drops, hopper and bin loading, shall be equipped with water sprays to minimize emissions of particulate matter. [District Rule 1302]
- 6. This equipment and associated operations shall not discharge an exhaust stream that exhibits opacity greater than twenty percent (Ringelmann 1).

[District Rules 204 and 401]

- 7. The owner/operator shall maintain a log of all material throughput amounts so as to ensure compliance with conditions 8 and 9 below. Additionally, a log shall be kept of all inspections, repairs, and maintenance on equipment. Such logs or records shall be maintained at either the facility or corporate office for at three (3) years and available to District, State, or Federal personnel upon request. [District Rule 204]
- 8. The daily ready-mix concrete throughput at this facility shall not exceed 6,500 Cubic Yards of Concrete in any consecutive twentyfour (24) hour period.

[District Rule 1303 - BACT]

9. The annual concrete throughput at this facility shall not exceed 195,000 Cubic Yards of Concrete in any consecutive twelve month period.

[District Rules 204 & 1303]

10. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
