## **CONDITIONS:**

1. This baghouse shall be functioning at all times that the Asphalt Batch Plant covered under Permit B001748 is in operation.

2. The owner/operator (o/o) shall have a maintenance plan for this baghouse. This plan, at a minimum, shall require a log which includes visual emissions determination on a weekly basis, recording of differential pressures across the baghouse and inspection/repairs frequency.

- 3. The o/o shall install, operate and maintain this dust collector in strict accord with those recommendations of the manufacturer/supplier, and sound engineering principles which produce minimum emissions of air contaminants.
- 4. The o/o shall log all bag replacements, repairs and non-scheduled maintenance. The log shall be kept current, on-site for a minimum of 2 years and provided to District personnel on request.
- 5. The o/o shall maintain an inventory of replacement bags on-site at all times which will ensure compliance with applicable Rules of District Regulation IV.
- 6. The o/o shall conduct compliance emissions tests relative to Rules 404 and 405 beginning in 1995 prior to November 30, and each year in which the plant operates more than 90 days. The o/o shall conduct emissions testing for particulates, oxides of nitrogen, volatile organic compounds and carbon monoxide in strict accord with all procedures described in the District's Compliance Test Procedural Manual. This testing for particulates is necessary to demonstrate compliance with District Rules 404 and 405. The District shall be notified no less than 10 working days prior to the test and receive the final test report of emissions no later than six weeks prior to the expiration date of this permit in those years applicable.
