### **Description:**

DUST COLLECTOR (LACQUER BLDG) consisting of: Manufactured by Donaldson Company (Torit & Day Div), a Model 96 HPT-8 Walk-On baghouse, equipped with a 25 hp fan generating 7500 cfm across 96 3" x 6" oval x 96" long bags of 954 sq ft surface area (for a 7.9 air to cloth ratio). This device vents the tanks, fillers and weigh-up hood in the Lacquer Building and discharges into the Biolfiltration unit.

#### **CONDITIONS:**

- 1. The owner/operator (o/o) shall install, operate and maintain this dust collector in strict accord with those recommendations of the manufacturer/supplier, and sound engineering principles which produce minimum emissions of air contaminants.
- 2. The o/o shall institute a program of maintenance which embraces at least weekly visible emission determinations and monthly visual inspections of all associated equipment (inclusive of the filters and their suspension systems).
- 3. The o/o shall log all the items in 2 above in addition to the cartridge replacements, repairs and non-scheduled maintenance. The log shall be kept current, on-site for a minimum of two (2) years and provided to District personnel on request.
- 4. The o/o shall maintain an inventory of replacement bags on-site at all times which will ensure compliance with applicable Rules of District Regulation IV.
- 5. This baghouse shall operate concurrently with the tanks, fillers and floor scales (via the weigh-up hood) in the Lacquer Building under valid District permit number B008522.
