Description:

BAGHOUSE #4 (AIR-SLIDE UNLOADING) consisting of: A Flex-Kleen Model 84-CTBS-24 baghouse, with 24 6" D by 84" L polyester bags totaling 254 square feet of filter area, operating at 1100 cfm of flow (for an air to cloth ratio of 4.3:1). This system includes a two hp rotary discharge valve.

CONDITIONS:

- 1. The owner/operator (o/o) shall maintain this baghouse in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants.
- 2. This baghouse shall operate concurrently with the air-slide unloading system portion of the Ingredient Handling System (B008779).
- 3. The o/o shall conduct a minimum program of inspection and maintenance on this equipment. The o/o shall maintain current and onsite for five (5) years a log of the following information, which shall be provided to District personnel upon request:
- a. Weekly baghouse stack observation date and result (using USEPA Method 22, and USEPA Method 9 if necessary);
- b. Quarterly bag and bag suspension system inspection date and results;
- c. Date of bag replacements; and,
- d. Date and nature of any system repairs.
- 4. This baghouse shall not discharge into the atmosphere an exhaust stream that exhibits greater than twenty percent opacity.
- 5. This baghouse shall discharge no more than 0.09 pounds per hour of PM10 at a maximum concentration of 0.01 grains/dscf at the operating conditions given in the above description (BACT). This equipment does not require a regularly scheduled emission
