## Description:

MIST COLLECTOR #16 (PROCESS LINE #1 COATER) consisting of:A Torit Model DMC-DQ1 mist collector, with 220 square feet of filter area, equipped with a 7.5 hp fan generating 2000 cfm of flow (for an air to cloth ratio of 9.1:1). This system includes a two hp rotary discharge valve.

#### **CONDITIONS:**

- 1.The owner/operator (o/o) shall maintain this equipment in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants.
- 2. This mist collector shall operate concurrently with the coater portion of Process Line #1 (B008780).
- 3. The o/o shall conduct a minimum program of inspection and maintenance on this equipment. The o/o shall maintain current and on-site for five (5) years a log of the following information, which shall be provided to District personnel upon request:
- a. Weekly mist collector stack observation date and result (using USEPA Method 22, and USEPA Method 9 if necessary);
- b. Quarterly filter and filter suspension system inspection date and results;
- c. Date of filter replacements; and,
- d. Date and nature of any system repairs.
- 4. This equipment shall not discharge into the atmosphere an exhaust stream that exhibits greater than twenty percent opacity.
- 5.This mist collector shall discharge no more than 0.17 pounds per hour of PM10 at a maximum concentration of 0.01 grains/dscf at the operating conditions given in the above description (BACT). This equipment does not require a regularly scheduled emission
