Description:

FLUE GAS DRYER AND DUST COLLECTION SYSTEM consisting of: A natural gas-fired flue gas dryer and hot (300 degree Fahrenheit) pulse jet-cleaned dust collector with bags totalling 1900 square feet of filter area and a 30 hp fan producing 7500 cfm (for an air to cloth ratio of 3.94:1). This system serves the Aumond pan conveyor.

CONDITIONS:

1. The owner/operator (o/o) shall maintain this baghouse in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants.

2. This baghouse shall operate concurrently with the Aumond pan conveyor.

3. The o/o shall conduct a minimum program of inspection and maintenance on this equipment. The o/o shall maintain current and onsite for five (5) years a log of the following information, which shall be provided to District, State or Federal personnel upon request:

a. Monthly baghouse stack observation date and result (using USEPA Method 22, and USEPA Method 9 if necessary);

b. Quarterly bag and bag suspension system inspection date and results;

c. Date of bag replacements; and,

d. Date and nature of any system repairs.

4. This baghouse shall be operated in compliance with 40 CFR 60 Subpart OOO - Standards of Performance for Nonmetallic Mineral Processing Plants.

5. This baghouse shall not discharge into the atmosphere an exhaust stream that exhibits greater than seven percent opacity (40 CFR
