Description:

DUST COLLECTOR (DC1 - SAND PILE) consisting of: a Donaldson-Torit Model DFT 2-8 baghouse equipped with a tbd number of bags totaling a tbd square feet of filter area, filtering an air flow rate to be determined (for an air to cloth ratio to be determined). This unit serves the sand pile feed to the 24 inch by 200 foot belt conveyor (B000368). Facility elevation is 3144 feet above sea level.

CONDITIONS:

1. The owner/operator (o/o) shall maintain this baghouse in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants.
2. This baghouse shall operate concurrently with the truck loading system sand pile (B000368).
3. This baghouse shall not discharge into the atmosphere an exhaust stream that exhibits greater than seven percent opacity (40 CFR 60.672(a)(2)).
4. This baghouse shall discharge at a maximum concentration of 0.01 grains/dscf at the operating conditions given in the above description (BACT). This equipment does not require a regularly scheduled emission compliance test. However, emission compliance testing may be required at the discretion of the District.
5. This baghouse shall be operated in compliance with applicable requirements of 40 CFR 60 Subpart OOO- Standards of Performance for Nonmetallic Mineral Processing Plants.

6. The o/o shall conduct a minimum program of inspection and maintenance on this equipment. The o/o shall maintain current and on-site for two (2) years a log of the following information, which shall be provided to District personnel upon request:

- a. Quarterly baghouse stack observation date and result (using USEPA Method 22, and USEPA Method 9 if necessary);
- b. Quarterly bag and bag suspension system inspection date and results;
- c. Date of bag replacements; and,
- d. Date and nature of any system repairs.

7. The o/o shall maintain on-site a minimum inventory of replacement bags that assures compliance with these conditions.
