GENERATOR BUILDING, 3-WAY NSCR CATALYST, GENERATOR 1, PHASE I, consisting of: EmPact Emission Control System located within the exhaust stack of NATURAL GAS IC ENGINE, PRIME GENERATOR, GEN 1 permitted as B012864; designed to reduce emissions of oxides of nitrogen (NOx), carbon monoxide (CO), hydrocarbons (HC), formaldehyde (CH<sub>2</sub>O), and Hazardous Air Pollutants (HAPs). Equipment Elevation is 261 feet above sea level.

#### **CONDITIONS:**

1. This air pollution control device(s), shall be installed, operated, and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles in a manner consistent with good air pollution control practice for minimizing emissions. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

2. This equipment shall be operated concurrently with the Natural Gas Fired generator with valid District permit B012864.
