NATURAL GAS IC ENGINE, COMPRESSOR, PLANT 2, CLARK 15, OXIDATION CATALYST (OXCAT) SYSTEM, PHASE I, consisting of: Oxidation Catalytic System is located within the exhaust stack of NATURAL GAS IC ENGINE, COMPRESSOR, PLANT 2, CLARK 15 permitted as B013096 designed to minimize emissions of VOC and CO and Toxic Air Contaminants (TACs). Equipment Elevation is 261 feet above sea level.

### **CONDITIONS:**

- 1. This air pollution control device(s), shall be installed, operated, and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles in a manner consistent with good air pollution control practice for minimizing emissions.
