- 2. A daily log of the VOC emissions shall be maintained and kept current, on-site for a minimum of two (2) years and provided to MDAQMD personnel on request. This log shall contain, at a minimum, the following information:
- a. Equipment used to apply coating
- b. Type of coating used and its VOC limit under the applicable Rule
- c. Quantity of coating used and its VOC content
- d. Total VOCs generated by b. and c. above if covered; and
- e. Type of material being coated.
- 3. All equipment used at this facility shall be operated and maintained in strict accord with those recommendations of the manufacturer/supplier.
- 4. The total mass of VOCs emitted from this operation without regard to where or how it is generated shall not exceed 25.0 tons/yr based on 8760 hr/yr.
