## **Description:**

SPRAY GUN consisting of: Building 873. Devilbiss, model number JGHV-530, serial number 2, airless spray gun. This equipment may be used outside of any spray booth. Paint will be used on vehicles and, therefore, shall comply with the rules mentioned in Condition number 1 below in their entirety.

#### **CONDITIONS:**

- 1. All coatings and solvents shall comply with District Rules 1115 and 1116 in their entirety. These rules pertain to Metal Product Coating Operations and Automotive Refinishing Operations.
- 2. No photochemically reactive portion of the coating is permitted. This includes the coating as purchased and any solvents which may be used as diluent, thinner, reducer or cleaner.
- 3. The owner/operator (o/o) shall operate only one piece of equipment described in this permit at a time and then in strict accord with the recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emission of air contaminants. Spray equipment shall be given unique identification marks attached thereto prior to use under this permit.
- 4. The o/o shall maintain a daily log which includes all of the following:
- a. use of all VOC, inclusive of all mentioned in Condition 1. above;
- b. quantity and description of all VOC containing materials mentioned in Condition 1. above; and
- c. starting and finishing times of operations.
