- 3. The log shall be maintained current, on-site for a minimum of 2 years and provided to District personnel on request. (Note: the daily log information provides the basis for the Toxic Emission Inventory consistent with AB 2588.)
- 4. This equipment shall be operated and maintained in strict accord with the recommedations of the manufacturer/supplier.
- 5. The total mass of VOCs emitted from this operation without regard to where or how it may be generated shall not exceed 25 tons/year based on 8760 hours per year of operation.
