Description:

STORAGE TANK, USED CRANKCASE OIL consisting of: One aboveground 7,000 gal used crankcase oil storage tank and three aboveground 7,000 gal oil tanks. Stacks are 6.5 feet in height and 1-inch in diameter. Equipment elevation is 1911 feet above sea level.

CONDITIONS:

1. This equipment shall be installed, operated, and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles in a manner consistent with good air pollution control practice for minimizing emissions. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

All of the components of this tank including but not limited to tanks, flanges, seals, pumps valves, meters, connectors, and other appurtenant equipment shall be installed, maintained and operated so as to prevent fugitive vapor leaks, fugitive liquid leaks and excess organic liquid drainage during transfer, storage, and handling operations.

3. This tank is limited to storing waste oil generated on-site by So Cal Gas Co.
