Description:

TANK #9 (BLDG 630) consisting of: Three storage tanks @ 5,000 gallon each, for used oil or contaminated fuel above the secondary containment 57,000 gallon, lined concreate, underground tank.

CONDITIONS:

- 1. Hazardous or toxic material shall not be stored in this tank. Only internal combustion engine crankcase drainage oil or contaminated fuel may be stored in these tanks.
- 2. The owner/operator (o/o) shall notify the District, in writing, thirty days prior to making any change in the type petroleum product stored in this tank. Compliance with District Rules shall be assured by obtaining a modified permit for the proposed petroleum product prior to change of product to be stored in this tank.
- 3. Used crankcase oil and contaminated fuel shall not be stored in the same tank at the same time.
- 4. The o/o shall maintain an operators log for this tank which, as a minimum, contains: the throughput, source of waste oil (contaminated fuel); date and volume (weight) of waste oil sent to outside disposers, and the hauler. The log shall be maintained on-site for at least 2 years and presented to District personnel upon request.

NOTE: This ATC is to remove one 5,000 gallon tank leaving three 5,000 gallon storage tanks remaining.
