distance from the top of the liquid to the top of the tank.

- 4. Parts shall be added or removed from the tank in a manner so as to prevent splashing.
- 5. Do not remove parts from the dip tank until the parts are visually dry and not dripping/leaking solvent. [1104(C)(2)(vi)(e)]
- 6. The hoist speed must be slow enough to prevent solvent vapors from being pushed and/or pulled out of the tank. The speed of the existing hoist must not exceed 30 feet per minute and any new or replacement hoist must not exceed 11.2 feet per minute.
- 7. An operator's log must be maintained which contains, as a minimum, the type of solvent in each tank, date and amount of solvent added, and a daily self-inspection checklist. This log shall be maintained current and on-site for a minimum of five (5) years and shall be provided to District, State or Federal personnel on request.
