CONDITIONS:

- 1. This equipment must not be operated unless it is vented to operating air pollution control equipment covered by valid District permit C000176 (44-155).
- 2. The owner/operator (o/o) shall comply with all District Rules and Regulations including, but not limited to, malfunction/breakdown notifications.
- 3. The o/o shall have a continuing program of maintenance/inspections in accord with manufacturer's recommendations and specifications which ensures compliance with District Rules.
- 4. The o/o shall maintain a log of all inspections, repairs and maintenance on this equipment and submit it to the District upon request. The log shall be kept for a minimum period of two years.
- 5. Daily logs shall be maintained for the operation of kiln No. 5 which includes but is not limited to the following:
- A. Hours of operation/day,
- B. Dates of major repairs and/or replacements,
- C. Type of fuel being used and the Btu/h of each,
- D. Dates of routine repairs.
- 6. The o/o shall comply with all requirements of Rule 1161 (Portland Cement Kilns) and provide to the District the following:
- A. The daily emissions for each operating day for this kiln system shall be recorded and/or calculated in a manner approved by the District. The data shall be submitted to the District within 30 days of the end of each calendar quarter.
- B. The o/o shall submit a written report of excess emisisons to the District Compliance supervisor for every calendar quarter. All quarterly reports shall be postmarked by the 30th day following the end of each calendar quarter.
