- 4.The maximum hourly throughput of material through this process shall not exceed 145 tons per hour (tph). (As a portable plant, see condition #4 with a process rate of less than 150 tph this unit is not subject to Title 40 CFR 60 subpart 000 per 40 CFR 60.670(c).)
- 5.A facility log shall be maintained on-site for at least two (2) years and made available to District personnel upon request. This log shall contain, as a minimum:
- a) The tons of product produced per day,
- b) Hours operated per day (hours meter reading at startup and shutdown each day),
- c) Average hourly production rate in tph (item a divided by item b),
- d) Yearly total throughput,

6.The facility shall not emit more than 12 tons/year of PM10. [District Rule 1302]

7.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
