### **CONDITIONS:**

- 1. This generator shall use diesel fuel whose sulfur content is = or < 0.05% on a weight/weight basis.
- 2.The owner/operator (o/o) shall maintain an operations log on-site for at least two (2) years and make available to District personnel on request. This log shall contain, as a minimum, the "hour meter" reading at the beginning and end of each day's operations, the total hours operated each day, and the gallons or pounds of fuel consumed. The o/o shall include the sulfur content of each delivery of diesel fuel. At the discretion of the District, the o/o shall collect a sample of diesel fuel and have it analyzed according to ASTM-2622-82 or other equivalent method for sulfur concentration and forward said results to the District upon receipt.
- 3. The o/o shall comply with all applicable District Rules including Regulation IV.
- 4. This generator shall be operated/maintained in strict accord with manufacturer's supplier's recommendations and/or sound engineering principles.
