Description:

CEMSTAR FEED SYSTEM, KILNS 6-7 consisting of: an iron additive hopper which feeds a conveyor belt (25 hp motor); which feeds the storage bin. The bin directly adds to the weigh feeders which discharge into kilns 6 and 7. Each kiln is fed approximately 5 ton/h of the iron additive from the 150 ton capacity bin. A 600 ton pile will be fed to hoppers for these 2 kilns as well as the one feeding kilns 1-5, by front end loader. Pick up points of the belt and bin storage are picked up by baghouse under District permit number C005148. New Baghouse C007345 picks up emissions from the weigh feeder belt to kiln 7. Electrical, piping, controls, valving and the necessary structures are included.

CONDITIONS:

- 1. Installation, operation and maintenance of this system shall be in strict accord with all the information submitted with the application. The submittal is incorporated in its entirety as an integral part of this permit and acts as specific limitations on this process.
- 2. This equipment shall not be operated unless it is vented to functioning baghouses under valid District permit numbers C005148 and C007345.
- 3. The 600 ton pile of additive, which is associated with this system, shall contain sufficient natural and/or added moisture to preclude violation of District rules pertaining to fugitive emissions, visible emissions and nuisance. Sufficient water and the necessary equipment for application shall be available and serviceable, respectively, for use.
