## **Description:**

BOILER consisting of:a Universal Boiler Works, Inc.; Model BF175W4-FE and whose serial number is 15623-1. This boiler is equipped with Nova LoNOx system, type CR Induced FGR. This boiler is designed to be fired on pipeline natural gas and is rated at 7.322 millions Btu/h input. The NOx emissions are expected to be approximately 20 ppm, v/v at stack conditions and 0.031 lb NO2/million Btu (equivalent to 0.23 lb/h) at maximum firing rate.

### **CONDITIONS:**

- 1. This equipment shall be tested to determine compliance with applicable limits through emission compliance testing, according to Rule 1157, not less than once every twelve (12) months. A tune-up may be performed in lieu of a compliance test for years when the annual heat input is less than 50,000 MMBtu.
- 2.Operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below.
- 3. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants.
- 4. This boiler shall only be fired with pipeline quality natural gas without the prior written approval of the APCO.
- 5. The owner/operator shall maintain a log for this equipment, which, at a minimum, contains the information specified below. This log shall be maintained current and on-site for a minimum of two (2) years and shall be provided to District personnel on request: a. Annual fuel use (MMcf) or heat input (MMBtu), on a calendar year basis.

- 6. This unit shall meet the following emission limits, when the annual heat input is greater than or equal to 50,000 MMBtu (corrected to 3% oxygen):
- a. Carbon monoxide less than 400 ppmv;
- b. NOx less than 70 ppmv, and/or 0.084 lbs/MMBtu of heat input, when operated on gaseous fuel;
- c. NOx less than 115 ppmv, and/or 0.150 lbs/MMBtu of heat input, when operated on liquid and/or solid fuels.
