The o/o shall not use any motor vehicle or mobile equipment coating that contains hexavalent chromium or cadmium (Section 17 CCR 93112 - Airborne Toxic Control Measure for Emissions of Hexavalent Chromium and Cadmium from Motor Vehicle and Mobile Equipment Coatings). Compliance with this condition shall be verified by the retention of MSDS sheets (or equivalent documentation of chemical content) for every applicable coating used at the facility for five (5) years, and provision of said information to District, State or Federal personnel upon request.
