- 3.Roadways, work areas and stockpiles shall be kept wetted to control fugitive dust. Equipment to properly wet the material being processed shall be maintained in operable condition on-site and used as necessary to assure compliance. [District Reg IV]
- 4. Visible emissions from this system shall not exceed an opacity equal to or greater than twenty percent (20%) for a period aggregating more than three (3) minutes in any one (1) hour, excluding uncombined water vapor. [District Rule 401(b)(1)]
- 5. This portable equipment cannot be operated at the same footprint (spot) for more than 365 consecutive days. (This system must be moved within this facility or moved to another facility for a valid business reason annually.)
- 6. The owner/operator shall limit the annual production (sum of all products) from this equipment to not more than 390,000 tons per each consecutive 12 month period (<15 tpy PM10). [District Reg XIII]
- 7. This equipment shall utilize water spray to control fugitive emissions. Water spray shall be directed onto aggregate material prior to processing the aggregate material. [District Regulation IV and Regulation XIII]
- 8.A facility log shall be maintained on-site for at least two (2) years and made available to District personnel upon request. This log shall contain, at a minimum:
- a. Tons of product produced per month, and
- b. Tons of product produced per year (consecutive 12 month period).
- 9. This equipment may be powered by line power or by a generator driven by an internal combustion engine with a valid District Permit or valid Portable Equipment Registration (PERP).
