BOILER, NATURAL GAS (BLDG 21, UNIT A) consisting of: One of three interconnected boilers providing comfort heat, all of which may be operating simultaneously: A RayPak model 2005A boiler, Serial Number 1607425875, equipped with a Bekaert 1.999 MMBtu/hour low NOx burner. Exhaust flow is approximately 250 acfm through a 42 foot high by 8 inch diameter stack.

CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or in a manner consistent with safety and good air pollution control practices for minimizing emissions. Furthermore, operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit is issued.

- 2. This equipment is limited to using only PUC-Regulated pipeline quality natural gas for fuel. [District Rules 431 and 1303(B)]
- 3. A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed unit operating time. [District Rule 204]
- 4. The owner/operator shall maintain an operations log for this equipment on-site and current for a minimum of two (2) years, and said log shall be provided to District personnel on request. The operations log shall include the following information at a minimum:
