SPRAY BOOTH HEATER, AEROSPACE consisting of: A heated air make up unit used for curing paint up to 180 degrees F. This unit is manufactured by California Pulse Inc., Model R2, Serial No. 0289, and is natural gas fired with a maximum rating of 2 MMBtu/hr. Burner is a Maxon, Model NP2-LE.

CONDITIONS:

- 1. This aerospace spray booth heater and associated equipment shall only be operated and maintained in strict accord with manufacturer's/supplier's recommendations and/or sound engineering principles. Operation of this equipment shall be conducted in compliance with data and specifications submitted with the application under which this permit is issued unless otherwise noted below. - 2. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants.
