3. This engine cannot remain at a location for more than twelve (12) consecutive months. A location is any single site at a building, structure, facility, or installation. Any engine (or engines) that replaces an engine at a location and that is intended to perform the same or similar function as the engine replaced will be included in calculating the consecutive time period.

[40 CFR 1068.30 "nonroad engine" (2)(iii)]

If the owner/operator intends to utilize this engine as a stationary engine, a permit modification must be submitted to the District prior to stationary operation, and the engine is subject to all stationary engine regulations.

- 4.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time. [District Rule 1302(C)(2)(a)]
- 5.The owner/operator shall maintain an operations log for this equipment, current and on-site (or at a central location), for a minimum of five (5) years, and this log shall be provided to District, State and/or Federal personnel, upon request. The log shall include, at a minimum, the information specified below:
- a. Date and location of each use; and,
- b. Duration of each use (in hours) and the type of use (regular prime use, emergency, testing & maintenance, etc.); and,
- c. Calendar year operation in terms of fuel consumption (in gallons or equivalent) and total hours. [Rule 1203(D)(1)(d)(ii)]
- 6. This equipment is a possible source of hazardous emissions and shall not be operated and/or located within 1,000 feet of a public or private school (kindergarten through 12th grade) of more than 12 students for more than 30 consecutive days without completing the notification required by California Health and Safety Code, Section 42301.6. The District must be notified immediately if this equipment is to operate, or be located, within 1,000 feet of a public school.
