NATURAL GAS, HOT WATER HEATER consisting of:a Sioux Corporation Model M-1 hot water heater equipped with two Power Flame Model M-2 natural gas fired burners each rated 1.15 MMBtu/Hr. Each burner stack is 20 feet high and 12 inch diameter.

CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or in a manner consistent with safety and good air pollution control practices for minimizing emissions. Furthermore, operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit is issued.

- 3. The owner/operator shall maintain an operations log for this equipment on-site and current for a minimum of two (2) years, and said log shall be provided to District personnel on request. The operations log shall include the following information at a minimum:
- a. Records of all maintenance, repairs, and tune-ups; and,
- b. Total fuel consumed on an annual basis: Fuel consumption can be calculated based on fuel purchase records, dedicated fuel meter readings, or other District approved method.

- 4.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
