#### **Description:**

BAGHOUSE consisting of: 44-004 Fabric Dust Collector DC-4 venting kiln feed system K 1 and 2 (covered by District permit B000215); Mikropul Baghouse, Model No. 121-S-10-20-TRHC, 2850 sq. ft. cloth area, 5.6 Air to Cloth ratio, Stack 17"d x 54"h, equipped with two Model No. 294 New York Blower fans, each rated at 40 hp and generating 8000 ACFM, operating @ 200 degrees F.

#### **CONDITIONS:**

- 1. The owner/operator (o/o) shall install, operate, and maintain this control equipment in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles.
- 2. The o/o shall institute a program of maintenance which embraces at least monthly visible emissions observations, monthly visual inspections of all associated equipment (inclusive of the bags and their suspension system), and monthly measurements of the pressure differential across the bag.
- 3. The o/o shall log all the items in conditions 2 above, including:
- a. Date of monthly visible emissions observations, whether or not visible emissions were observed from the stack, and maintenance procedure following if emissions were observed.
- b. Date of monthly inspection and actions taken on equipment found to be operating below standards.
- c. Date of pressure differential reading, whether or not it is within appropriate range, and maintenance procedure following if found to be outside of range.
- 4. The o/o shall maintain the log current and onsite for a minimum of five (5) years and provide it to district personnel upon request.

- 5. The o/o shall maintain an inventory of the minimum number of replacement bags onsite at all times which ensures compliance with District rules.
- 6. The o/o shall install and maintain a device which measures the pressure differential across the bags if one is not provided with the unit. This unit shall be operated within a range of four (4) to six (6) inches of water column as determined on the pressure differential device.
- 7. The baghouse shall operate concurrently with the equipment described in district permit B000215.
- 8. This baghouse shall discharge no more than 4.11 lb/hour at a maximum concentration of 0.03 gr/dSCF at the operating conditions described in the above description.
- 9. Within 180 days from the initial start-up of this unit, the o/o shall conduct emissions testing in strict accord with all procedures described in the District's Compliance Test Procedural Manual. This testing is necessary to demonstrate compliance with permit conditions in 7 above and District Rules 404 and 405. The District shall be notified no less than 10 working days prior to the test and receive the final test report of emissions no later than 45 days subsequent to the final day of on-site sampling and measurement.
- 10. The o/o shall conduct compliance tests relative to District Rules 404 and 405 and these conditions. Testing shall be every five (5) years starting in 2002 and the test results submitted to the District not later than six (6) weeks prior to the expiration date of this permit in those years applicable.
