CONDITIONS:

- 1. The owner/operator, o/o, shall install, operate and maintain this sulfur oxides reduction device in strict accord with those recommendations of the manufacturer/supplier.
- 2. The o/o shall institute a program of maintenance, which shall be determined subsequent to final design configurations. These final design configurations shall be submitted to the District within 90 days of the issuing of the complete letter.
- 3. The o/o shall log all the items in 2 above in addition to bag replacements, repairs and non-scheduled maintenance. The log shall be kept current, on-site for a minimum of 5 years and provided to District personnel on request.
- 4. This equipment shall operate concurrently with the Kiln and/or Raw Mill Grinding System under valid District permit numbers B007435 and B007439.
- 5. This equipment shall discharge no more than 780 lb of sulfur oxides/day (calculated as sulfur dioxide), based on the operating conditions described above.
- 6. Within 180 days from the initial start-up of this unit, the o/o shall conduct emissions testing in strict accord with all procedures
